



BASIC UNIVERSAL TREATMENT CURRICULUM TRAINING PROGRAM FOR ADDICTION PROFESSIONALS

The National Authority for the Campaign against Alcohol and Drug Abuse (NACADA) is a State Corporation in the Ministry of Interior and Coordination of National Government. NACADA was established by the NACADA Act of 2012 (CAP 121B) of the Laws of Kenya. Broadly, NACADA was established to coordinate a multi-sectoral effort aimed at preventing, controlling and mitigating alcohol and drug abuse in Kenya. The Authority is mandated to provide and facilitate the development and operation of rehabilitation facilities, programs and standards for persons suffering from substance use disorders. Certification of addiction professionals is one step in that direction. The objective is to ensure quality treatment and rehabilitation to persons with substance use disorders by certifying addiction professionals.

To ensure that the Addiction Professionals acquire set competencies and skills thereby comply with the National Standards for Treatment and Rehabilitation of Persons with Substance Use Disorders

ELIGIBILITY

Degree in Social Sciences, Medicine, Education or related field (Pharmacy)
Diploma in Addiction Counselling, Psychology, Social Work, Education and Psychiatric Nursing.

COST

The training cost is **Ksh. 25,000** per phase, which will cater for course materials, information packs, snacks and lunch. Participants shall be expected to meet the cost of accommodation, travel and any other expenses. A certificate shall be awarded after every phase and upon successful completion and passing of the Basic UTC exam participants shall be accredited.
