#### NACADA GIVEN MORE POWER TO ENFORCE LAWS ON ALCOHOL ABUSE

The Cabinet Secretary, Ministry of Interior and National Administration Prof. Kithure Kindiki has strengthened the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) legal mandate to enforce the Alcoholic Drinks Control Act (ADCA), 2010, as well as the NACADA Act, 2012 following the gazettement of Authorized Officers as is required by the two statutes.

With this new development, in line with section 51 of ADCA 2010, NACADA's Authorized officers may, at any reasonable time, enter any place in which they believe on reasonable grounds that a person or persons is in any way contravening the provisions of the law.

Reacting to the news, NACADA Chief Executive Officer Dr. Anthony Omerikwa, MBS, observed that the development will allow the Authority to execute its compliance and enforcement mandate in a legally binding environment.

"I want to sincerely extend the Authority's gratitude to the Cabinet Secretary, Ministry of Interior and National Administration for this affirmation of the government's steadfast support to the campaign against alcohol and drug abuse in the country. This now means that NACADA can fully implement its supply suppression strategies confidently with the full backing of the law. These are some of the teething problems that have been acting as stumbling blocks to the effective implementation of our mandate but I am glad that we are now past that," said Omerikwa.

According to Section 52 of the ADCA 2010, when inspecting any place, an authorized officer may; examine an alcoholic drink or anything referred to in that section; and require any person in such place to produce for inspection, in the manner and form requested by the officer, the alcoholic drink or thing; open or require any person in the place to open any container or package found in the place that the officer believes on reasonable grounds contains the alcoholic drink or thing; conduct any test or analysis or take any measurements;

or require any person found in the place to produce for inspection or copying, any written or electronic information that is relevant to the administration or enforcement of the Act.

"This is welcome news for us, especially at this time when we are heading to the festive season. I want to assure the public that moving forward, we shall do things differently to ensure that the law is followed as expected. We are also calling on all stakeholders in the alcoholic drinks space to play within the rules to avoid legal action," added Omerikwa.

In a gazette notice published on Friday 1st December 2023, the Cabinet Secretary listed the names of the officers who with the consent of an occupant or under the authority of a warrant issued by a magistrate or judge of the High Court authorizing the person named in the warrant may enter and inspect a dwelling place. The law further clarifies that the time of such entry shall be between six o'clock in the forenoon and six o'clock in the afternoon of any day of the week.

NACADA's officers executing the warrant shall not use force unless they are accompanied by a police officer and the use of force is specifically authorized in the warrant. To ensure the proper execution of duties by the authorized officers the law prohibits obstruction or hindrance, or knowingly making a false or misleading statement to an authorized officer who is carrying out duties.

Previously, NACADA had to rely on the National Police Service officers to enforce its laws. The latest development affords officers of the Authority operational independence, and they may request the support of police officers only where necessary.

NACADA on November 29th 2023 held a meeting at the Kenya Institute of Curriculum Development (KICD) with religious leaders drawn from various faith institutions. The meeting aimed at determining the role of religious institutions in the prevention and management of alcohol and drug abuse.

Representatives from various religious institutions such as The Supreme Council of Kenya Muslims (SUPKEM), Association of Pentecostal and Evangelical Clergy of Kenya (APECK), were present. The religious leaders came ready to contribute to a successful session. Acknowledging the gravity of the problem that is drug and alcohol abuse in Kenya, the men of cloth underscored that religion has a key role to play if we are to win this war.

Echoing the Interior Cabinet Secretary Prof Kithure Kindiki's remarks, the CEO emphasized that the three threats we face in Kenya are: terrorism, banditry and alcohol and drug abuse. He said, "unlike the first two threats, we know the enemy in substance abuse. We know the enemy by name. One is called ethanol, another is called Rohypnol."

"Unlike the other two, this fight is not won by guns or uniforms. It is fought through religious motivation, understanding, emotional support and care." In emphasizing the importance of the voice of the mosque and church in the fight against alcohol and drug abuse, he said "You can't miss a mosque or a church anywhere in the world."

The Board Chairperson Rev. Dr. Stephen Mairori, EBS said "we are the value system of our nation. We need to be intentional and strengthen the partnership with religious institutions."

Religious leaders were called to emulate Sheikh Jamaludin Osman, the Jamia Mosque Imam who gave a very spirited lecture to congregants in a mosque while speaking against the recent rise of drug abuse among youths in South B and C.

NACADA Board member Hassan Ole Naado said, "All of us gathered here are the NACADA army, shaping humanity in our country. We are the people that the public turn to for hope. We should leave this place with practical solutions in the fight against alcohol and drug abuse."

Fredrick Ngugi, NACADA Board member added that, "Our resolutions should focus on new thinking in tracking alcohol and drug abuse. We should lead in community engagement because this generation is in our hands."

Finally, the religious leaders issued a joint statement on their commitment to the campaign against alcohol and drug abuse.

The campaign against alcohol and drug abuse requires a concerted effort and this can only be achieved through strategic partnerships. This was best exemplified through high-level meetings that saw the Authority's CEO Dr. Anthony Omerikwa, MBS, hold strategic meetings with his counterparts from the Kenya Bureau of Standards (KEBS) and the Anti-Counterfeit Authority (ACA) in Nairobi.

The meeting with the Chief Executive Officer at the ACA Dr. Robi Mbugua Njoroge was aimed at forging a coordinated approach to the fight against counterfeits and drug abuse. "As NACADA we have to bring on board all stakeholders in the campaign against alcohol and drug abuse. The Anti-Counterfeit Authority is one such strategic collaborator in this endeavor because the consumption of fake products presents a health challenge to the users," said Dr. Omerikwa.

The ACA's Executive Director, Dr. Robi Mbugua Njoroge, highlighted the pivotal role played by both institutions in addressing the emerging challenges of counterfeit alcohol and drug abuse.

"Our joint efforts are crucial in protecting consumers from the dangers of fake and illegal alcoholic drinks and other substances of abuse," remarked Dr. Njoroge.

In a separate meeting during a courtesy call paid to the NACADA Chief Executive Officer, the Kenya Bureau of Standards (KEBS) Managing Director Esther Ngari highlighted the need for collaboration between the respective agencies under a multiagency approach.

Both NACADA and KEBS have an interest in ensuring that the country has universally accepted standards that guide operations in our respective spaces, and especially those that will give impetus to the campaign against alcohol and drug abuse. As government agencies, we shall work together towards the development and promotion of quality as a means of mitigating against harmful products finding their way into the market thus putting the lives of Kenyans at risk," added the Managing Director.

Underlining the need for mutual collaboration between the two organizations, NACADA Chief Executive Officer Dr. Anthony Omerikwa also pointed at joint activities as part of the strategies that will yield results.

"Both our organizations have compliance and enforcement teams which we shall deploy to mount joint operations. As we continue exploring other areas of partnership, we shall also be working towards acquiring ISO certification as one of the ways through which to strengthen our processes, "he added. The Authority continues to pursue collaborations with all stakeholders to guarantee a multi-faceted approach to the challenge of alcohol and drug abuse in the country.

Among the core functions of the Authority is to facilitate the development and operation of rehabilitation facilities and programmes in conjunction with other stake holders. The Authority has been working with county governments and will continue to work with them to enhance access to professional and affordable treatment and rehabilitation services and program.

To actualize this, the Authority on the 24th of November 2023 officially opened the Kiowa Treatment and Rehabilitation Centre in Bomet County. Recognizing the importance of working with county governments in order to rid the county of drugs and alcohol abuse, the facility was put up through a partnership with the County Government of Bomet.

The event was graced by Her Excellency the Spouse of the Deputy President Pastor Dorcas Rigathi, EGH, Bomet Governor His Excellency, Hillary Barchok and other esteemed guests. "I understand there is a 22 per cent prevalence of drugs in this county. That is very bad and if we don't do something Governor, this county will have a big problem." said Dr. Rigathi.


Pastor Dorcas called on all counties to open their doors for such facilities as a way of safeguarding the future of the country. "Those selling poison to our children must close their businesses and get something else to do." She cautioned. "This facility will not only help the people of Bomet but it is a facility that is meant for all of us."

#### NACADA CAMPAIGNS FOR SAFE DRIVING DURING FESTIVE SEASON

The National Authority for the Campaign Against Alcohol and Drug Abuse worked with the National Transport and Safety Authority (NTSA) during the festive season towards sensitization and the campaigning for safe driving habits on the roads.

This came as a result of a commitment that was made between NACADA and NTSA during the World Day of Remembrance for Road Traffic Crash Victims (WDoR) to work together. The remembrance was commemorated in Nakuru County on November 19, 2023. On this day, countries remember the many lives lost on roads due to traffic crashes.

Speaking during the function, NACADA Chief Executive Officer Dr. Anthony Omerikwa, MBS, observed that drinking alcohol and driving is a well-studied risk factor for road traffic crashes, injuries, and deaths.

"Driving under the influence of alcohol or any other drug is one of the major risk factors for impaired judgment and eventual fatal road crashes. Drugs affect the central nervous system and in the process alter the normal functioning of the brain which in turn leads to compromised decisions on the road. We are therefore calling on all road users to stay away from these substances as a way of ensuring safety on our roads during this festive season," said Dr. Omerikwa.

Speaking during the same event, the Director General of the NTSA George Njao, urged road users to exercise caution on the roads by observing all the traffic regulations to curb the rising number of accidents and fatalities on Kenyan roads.

"How many people will we be losing every other day if we do not sensitize the public on proper and safe use of our roads? "he posed.

The theme of this year's day was "Remember, Support, Act" paying tribute to lives lost in road traffic crashes, acknowledging the efforts of emergency services, and advocating for safe roads.

"Stay away from alcohol and drug use to promote safety on our roads. We shall work closely with NTSA to draw the public's attention to road crashes, consequences, and measures to prevent them," added Dr. Omerikwa.

Statistics show that 1.3 million people lose their lives globally, and 50 million more are injured. Many of these deaths and injuries are preventable, with over 80% of these incidences being behavior-related-speeding, drunk driving among others.

Kenya is not turning a blind eye to the shisha spectacle. In a bold move to safeguard public health, the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) took decisive action on December 22, 2023, intensifying efforts to curb the use of shisha in Kenya. Back in 2017, the government threw down the gauntlet with the Public Health (Control of Shisha Smoking) Rules. It is a clear "no" to the importation, manufacture, sale, use, advertising, promotion, or distribution of shisha. But here's the twist – despite the ban, some entertainment spots are defiantly serving up the forbidden fruit. Is it time for a strategic retreat or an all-out offensive?

Shisha, also known as hookah or water pipe, has gained popularity, particularly among young people. It is a single or multi-stemmed instrument designed for heating or vaporizing and smoking tobacco or flavored tobacco. The apparatus consists of a head containing flavored tobacco separated from burning coal or charcoal by foil, connected to a system of airtight tubes that pass tobacco smoke into a water basin, often glass-based. Contrary to popular belief, passing shisha smoke through water does not purify it. Moreover, shisha, at times, is laced with substances such as cannabis, hashish, or opium to enhance its potency.

Let us debunk a myth or two. People have argued that shisha does not pose any health risk or that if it does, it is less risky than other tobacco products. Many believe that shisha smoke does not contain nicotine or carbon monoxide (CO) and that smoking shisha does not lead to infections or respiratory, dental, or cardiovascular morbidity. Unbeknownst to them, shisha often contains the same type of tobacco as is contained in cigarettes which means that the same health problems likely to develop for cigarette smokers are the same risks that shisha smokers are at risk of developing.

Additionally, shisha can contain nicotine, the addictive ingredient in cigarettes, which means that one can become addicted to smoking shisha. A World Health Organization (WHO) study has estimated that a one-hour session of smoking shisha can be the same as smoking 100 or more cigarettes. While there may be questions in regards to the effects of secondhand shisha smoke due to the burning of coal while smoking shisha, way more carbon monoxide is given off than while smoking cigarettes thereby posing a great risk of carbon monoxide poisoning.

So what's the legal status of shisha in Kenya? Following the growing popularity of the substance, the government through the Cabinet Secretary responsible for matters of health prescribed the Public Health (Control of Shisha Smoking) Rules, Legal Notice No 292 of 2017 which bans the importation, manufacture, sale, use, advertising, promotion or distribution of shisha in Kenya. Despite the ban and the associated health risks, many entertainment spots continue to sell it in defiance of the law.


So should the government then consider legalizing shisha and effect regulations as has been done for other tobacco and tobacco products or continue enforcing the ban with the hope that people will get to know of the risk posed by shisha smoking and eventually stop?

Through out December and the festive season, the Authority in partnership with the National Transport and Safety Authority (NTSA) conducted roadshows in multiple counties.

This was following a commitment made at the World Day of Remembrance (WDoR) by NACADA and NTSA to work together during the festive season to campaign for road safety which culminated in a campaign dubbed 'Usalama barabarani'. The campaign/roadshow was officially flagged off by The Cabinet Secretary for Roads and Transport, Hon. Kipchumba Murkomen, EGH, in an event held at Railways Station in Nairobi's CBD on December 18 2023. Hon. Murkomen said, "I urge all drivers, cyclists and pedestrians to familiarize themselves with the rules and be ambassadors of road safety while using the roads."

With mostly holiday tunes rocking from the back of the truck, the roadshow went to three counties, namely: Nairobi, Uasin Gishu and Busia. The Nairobi roadshow took place from the 11th to the 16th of December where there was no single street or road in the capital that didn't bear the truck's tire marks afterwards.

However, the highlight of the Nairobi roadshow was when the truck pulled up to the Jacaranda grounds in Donholm. There, a huge crowd comprising of men, women, the old and the young was awaiting us. The crowd, which could fill a ministadium, was full with anticipation for what the convoy had to say.

The crowd was first entertained by a group of dancers who jammed to the tunes of a fire DJ before they were cautioned on the elephant in the room that was drunk driving.

The following week, the air waves from the truck's sound system rocked Eldoret Town and the larger parts of Uasin Gishu County. There, the residents were occasionally treated to the local hit "Mali Safi Chito" sang by one of their own.

Finally, the roadshow closed its curtains the following week in Busia where the Authority's Chief Executive Officer Dr. Anthony Omerikwa, MBS, was present. The roadshow in Busia brought together a host of stakeholders including The Police, Local Administration, The County government and the public.

Observing the need for close cooperation between all these stakeholders, the CEO called for information sharing as one of the most effective strategies to counter alcohol and drug abuse in the County and the larger Western Region, which in our latest national survey ranks top in consumption of alcohol in the country.

# IHURURU TREATMENT AND REHABILITATION HOSPITAL OFFICIALLY OPENED BY HER EXCELLENCY PASTOR DORCAS RIGATHI

In a society where alcohol and drug addiction cast a shadow over the futures of countless young individuals, there is hope, dedication, and compassion for individuals determined to make a difference. Pastor Dorcas Rigathi, the Spouse of the Deputy President, is one such beacon of light, breaking barriers and rebuilding lives through her initiatives in the campaign against alcohol and drug abuse.

On 28th November 2023, in Tetu, Nyeri County, Her Excellency Pastor Dorcas officially opened the Ihururu Treatment and Rehabilitation Hospital. The 90-bed capacity facility opened its doors in September 2023 after an assessment by the National Authority for the Campaign Against Drug and Alcohol Abuse (NACADA) and official accreditation by the Interior and National Administration Cabinet Secretary, Prof. Kithure Kindiki on 8th November 2023. This Level IV hospital seeks to offer holistic services for persons with substance use disorders.

Recognizing the limitations of the existing rehabilitation facilities, she advocated for the establishment of dedicated wards in both national and county government hospitals. "I intend to pursue the Ministry of Health at both the national and county level to be able to open upwards in their facilities to enable us to rehabilitate our youth. The crisis is huge, and even when we combine all the accredited rehabilitation centers in the country, it is impossible to contain the crisis in our nation." She said.

Acknowledging the financial burden associated with rehabilitation, Pastor Dorcas Rigathi also revealed plans to collaborate with the National Health Insurance Fund (NHIF).

By extending coverage to include rehabilitation and treatment for drug and alcohol addiction, she aims to make these vital services more accessible to those in need. She affirmed, "It is a bold step towards ensuring that the fight against addiction is not only a global concern but also an affordable and attainable goal for everyone." She sponsored the admission of over 40 young men who voluntarily registered for treatment.

Speaking during the launch, the Nyeri Governor, His Excellency Mutahi Kahiga pledged to mobilize governors from the Mount Kenya region to revive rehabilitation centers that have been neglected as well as equip those already in existence.

Others present were NACADA Board Chairperson Rev. Dr. Stephen Mairori, NACADA Board Member Rev. Fredrick Ngugi, NACADA CEO Dr. Anthony Omerikwa, Deputy Governor Kinaniri Warui, Tetu MP Geoffrey Wandeto among others.


